UPDATE: IS YOUR BUSINESS TO BUSINESS LEASE GOVERNED BY THE RETAIL LEASES ACT 2003 (VIC)?

After entering into a lease contract for a cold storage facility in 2012, a dispute arose between the tenant and the landlord. The issue was whether or not the lease was considered to be a “retail lease” based on the permitted use. Initially, the facility was found not to be a retail premises. This decision was overturned and then revisited on appeal.
